## INVITATION FOR EXPRESSION OF INTEREST (EOI)

Auqaf & Religious Affairs Department, Government of Punjab through its autonomous Body, Namely Punjab Auqaf Organization intends to hire services of Consulting Firm for the scheme titled "Integrated Master Planning & Development of Shrine Complex Baba Bulleh Shah, Kasur".

Expression of Interest (EOI) is invited under PPRA Rule 2014 (Amended 2023) from the firms registered with Pakistan Council of Architects and Town Planners (PCATP) or Pakistan Engineering Council (PEC) in relevant fields up to 30-06-2024.

The interested consultancy firms having experience of similar nature works may apply for selection along-with the following information supported with necessarily documents:

1. Name of firm / address of the registered office with telephone / fax number and e-mail address including organization chart showing management structure. Format for letter of EOI application.
2. Memorandum of Articles of Association of the firms.
3. Certificate of Registration with the Pakistan Council of Architects and Town Planners (PCATP) or registration with Pakistan Engineering Council in relevant fields along-with the valid renewal letter upto 30.06.2024.
4. Copy of Registration with Securities and Exchange Commission of Pakistan or Registrar of Firms.
5. Only relevant Project wise experience with time duration for each Project.
6. List of similar nature works completed by the Firm during the past ten years, indicating total cost of such works and cost of Consultancy Services received against those works along with date of start and date of completion. The Consultant Firm should furnish details of technical experience as on the date of submission of EOI.
7. An undertaking by the consultants / firms / JVs to the effect that "Neither the firm / consultants / JVs nor its Directors / Stakeholders, as a whole or as a part of the firm have even been Black-listed / defaulted by any Government Agency / Department / Organization and also that the information supplied by the consultants / firm / JVs is correct".
8. Certificate / Affidavit that the consultants / firms / JVs is not in litigation with any client or Government Department.
9. Audit Statement of account for the last 03-years including the Audited Balance Sheet and Profit & Loss Account of the Bidder (of each member in case of a JV).
10. Details of net worth, annual turnover & net cash accruals duly filled and signed.
11. Maximum three (03) numbers of firms are allowed to make JV. The same firm shall not be allowed to submit EOI individually and in JV with any other firm. Every JV shall be unique. For international firms, it is mandatory to make JV with local firm/firms.
12. List of permanent professional staff along with CVs of relevant core staff showing relevant project wise experience with exact time duration for each project. The Bidder should furnish details of technical experience of core team/ professional staff as on the date of submission of EOI.

Interested firms may obtain / purchase set of prequalification documents / criteria for short listing / prequalification, on request from the office of the Director Projects Auqaf, 3<sup>rd</sup> floor Aiwan-e-Auqaf, Lahore on payment of Rs. 5000/- only, (Not Refundable). Prequalified firm shall be invited to participate in the subsequent procurement proceedings. EOI must reach in the office of the Director Projects Auqaf, 3<sup>rd</sup> Floor Aiwan-e-Auqaf, near Lahore High Court, Lahore upto 10-10-2023 not later than 12.00 Hrs and will be opened on same day at 12.30 P.M in the presence of representative of the participating firms.

Auqaf & Religious Affairs Department reserves the right to reject all the applications at any time prior to the acceptance, on the basis of valid reasons and no claim whatsoever, shall be entertained on this account. If at any stage concealment / distortion of fact is detected it would be sufficient cause to reject the application.
