2. All Proposals / Tenders must be accompanied by Earnest Money / bid security @2% of Estimated Cost (refundable) in shape of Bank Draft / CDR in the name of Director Projects Auqaf. The bidder shall submit scanned copy of bid security on E-PADS and original Bank Draft / CDR will be submitted to office of the Director Projects Auqaf, as addressed below, before opening of tender.
3. Bidding Documents are immediately available after date of publication at E-PADS website and can be downloaded before closing date & time.
4. In case opening date(s) is declared as a public holiday by the Government, next working date shall be deemed to be date for submission & opening of tender(s) at the same time & place. The bids will be received only from those firms who are registered with PPRA for E-Procurement on E-PADS for tendering through email addresses which were provided by them to PPRA at time of their registration.

The interested bidders are requested to submit their bids / proposals online through E-PADS at <https://eprocure.gov.pk> before opening date and original bids / proposals must be submitted at office of the Director Projects Auqaf, as addressed below, before opening of tender. **On or before 01:00 PM on 16-04-2025.** The Bids will be opened by the committee constituted for the purpose, on same day at 02:00 PM in the presence of bidder's representatives who choose to attend the opening session to be held at the office as addressed below, before opening of tender.
