2. All proposals / tenders must be accompanied by earnest money / bid security @2% of estimated cost (refundable) in shape of bank draft / CDR in the name of Director Projects Auqaf. The bidder shall submit scanned copy of bid security with CNIC copy on E-PADS and original bank draft / CDR with CNIC copy will be submitted to office of the Director Projects Auqaf, as addressed below, before opening of tender.

The bids will be opened by the committee constituted for the purpose, on same day at 02:00 PM, in the presence of bidder's representatives who choose to attend the opening session to be held at the office as addressed below, before opening of tender.
