

Single Stage Two Envelope Bidding Procedure of principal method of procurement (i.e. opening of technical proposals and financial competitive bidding) will be used by adopting responsive in technical bid and **Least Cost Based Selection (LCBS) Technique** for the subject procurement, in line with the Public Procurement Rules, 2014 and any Regulations, Regulatory Guides, Procurement guidelines or instructions issued by the PPRA authority (from time to time).
2. All proposals / tenders must be accompanied by earnest money / bid security @2% of estimated cost (refundable) in shape of bank draft / CDR in the name of Director Projects Auqaf. The bidder shall submit scanned copy of bid security with CNIC copy on E-PADS and original bank draft / CDR with CNIC copy will be submitted to office of the Director Projects Auqaf, as addressed below, before opening of tender.
3. Bidding Documents are immediately available after publication at E-PADS website and can be downloaded before closing date & time.
4. In case opening date(s) is declared as a public holiday by the government, next working date shall be deemed to be date for submission & opening of tender(s) at the same time & place. The bids will be received only from those firms who are registered with PPRA for E-Procurement on E-PADS for tendering through email addresses which were provided by them to PPRA at the time of their registration.
5. The interested bidders are requested to submit their bids / proposals online through E-PADS at <https://eprocure.gov.pk>. On or before 01:00 PM on 26-09-2025. The bids will be opened by the committee constituted for the purpose, on same day at 02:00 PM, in the presence of bidder's representatives who choose to attend the opening session to be held at the office as addressed below, before opening of tender.
